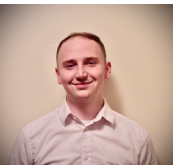
Farewell: David Pribulka, Ferguson Township Manager

Township Manager Recruitment Efforts

The Ferguson Township Board of Supervisors is engaged with a professional firm, GovHR, to lead the Ferguson Township Manager recruitment efforts.

The application period has closed, with 23 applicants applying for the position. The search has been extensive and vetted to ensure the most qualified candidate fills the position and serves on behalf of the residents of Ferguson Township.



As of March 29, 2022, the first round of interviews are scheduled with the Board of Supervisors, with a second round to be scheduled after all selected applicants have interviewed.

Recreation, Parks, & Open Spaces Plan Update

On April 5, 2022 at the Ferguson Township Board of Supervisors Meeting, staff members from Herbert, Rowland and Grubic (HRG), Tracy Strickland & Nikki Mendinski, provided an update to the board about the Recreation, Parks, and Open Spaces Plan that the township has engaged in. The RPOS Plan provided to the board laid out a variety of goals that are to be achieved by the plan, including new inventory of Township parks and recreation facilities, fresh analysis of community needs and issues, along with reviewing and updating recommendations for:



- *Actions, Priorities, Implementation and Potential Costs*
- *Master Site Development Plans for two (2) parks: Fairbrook Park & Greenbriar-Saybrook Park*

A series of public input meetings and surveys have occurred since 2021, with stations set up at the Winter Market of 2021, an ongoing citizen survey, and a series of meetings in January 2022 hosted by Ferguson Township. These meetings and surveys have asked Ferguson residents to identify areas in parks in the township that are seen as a "strength, opportunity, or threat" to the prosperity of the park and the township, along with an "idea wall" that asked residents to provide ideas for improvements to parks and open spaces in Ferguson Township.

The Board of Supervisors plans to review the presentation and data that has been gathered up to April 2022 to move towards a work session related to the plan tentatively in May 2022. HRG will continue to conduct surveys and arrange "Key Person & Stakeholder Interviews" relating to the myriad of parks and open spaces in Ferguson Township, with focus groups of local sports organizations, township staff, Centre Region Parks & Recreation, and civic groups.

Administration News

Songbird Sanctuary Park Master Plan Approved

The Board of Supervisors approved a resolution, February 1, 2022, to approve and adopt of Songbird Sanctuary Park Master Plan by resolution. Master planning for this park has been underway since 2019 with a steering committee, comprised of staff and residents, organized to have a multidisciplinary approach for a collaborative methodology. Back in July of 2019, the committee welcomed a combined total of 20 or more residents at the cul-de-sac on Owens Drive to participate in the master planning process. Ferguson Township also invited residents to complete an online survey to identify and prioritize their hopes for the park.



The Township acquired the 8.99-acre property that is bounded by Owens Drive and Blue Course Drive. Guiding principles that informed the master planning process focused on the passive recreation and environmental benefits of the site. Since the first meeting, held April 8, 2019, the steering committee engaged the Parks and Recreation Committee, the community, and staff throughout the park master planning process for continued involvement and input to present a final master plan to the Board that reflects community interests and park needs. The Master Plan rendering will be made part of the resolution and presented to the Board of Supervisors for their consideration on Tuesday, February 1. Residents are encouraged to email Interim Township Manager Centrice Martin with questions on the master planning process for the prefinal draft of Songbird Sanctuary Park Master Plan.

Proclamations: Lunar New Year, Black History Month, & Women's History Month Celebrations

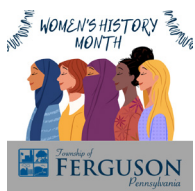


The Ferguson Township Board of Supervisors were proud to honor the diversity of the Centre Region by issuing proclamations for the Lunar New Year, Black History Month, and Women's History Month.

Proclamations for these holidays and celebrations are meant to highlight the creative and cultural contributions of Asian Pacific Desi American residents, African-American residents, and women across the Centre Region, and all proclamations were the first of their kind for Ferguson Township.



January saw the Board issue the 2022 Lunar New Year proclamation, February for Black History Month, and March for Women's History Month. Adding to the gravity of the Women's History Month proclamation, the Ferguson Township Board of Supervisors, for the first time in its history, is comprised of an all-female roster.



The Board will continue to be conscious of upcoming cultural and societal celebrations, and will always be sure to consider honoring these events to make residents in our community feel welcome and heard in their local government.

CRCOG Regional Refuse and Recycling Pilot Program

The Centre Region Council of Governments (CRCOG) Regional Refuse and Recycling Program serves residents of Ferguson Township as well as Benner, College, Harris and Patton townships as their designated refuse and recycling agent. CRCOG initiated a pilot program for refuse and recycling collection start time at 6:00 a.m. instead of 7:00 a.m. between Memorial Day and Labor Day of this year. The intent of the pilot program is to assess the impact, or success, of the change and to more fully understand the benefits and any issues that arise, before permanent changes are considered.



In response to this program, the Ferguson Township Board of Supervisors are seeking input to understand how to advocate for you in response to this pilot program.

We are asking that residents submit their comments by responding to the **Pilot Refuse and Recycle Program Online Comment Form**. This information will be shared and reviewed by Ferguson Township Board of Supervisors and staff as well as CRCOG to determine how best to meet the needs of township residents and expressed public health concerns of Waste Management employees post pilot program.

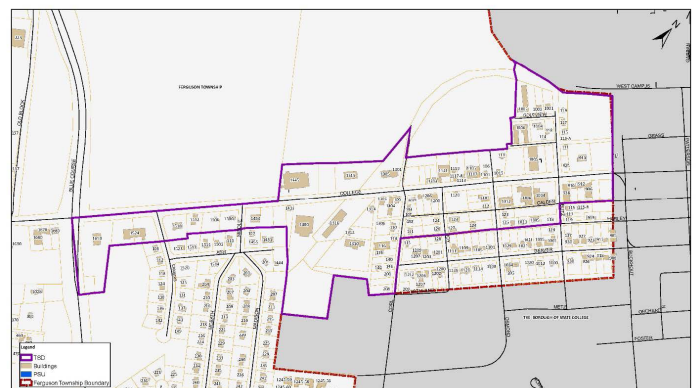

Planned Rewrite of Terraced Streetscape Zoning District

Since its inception in 2011, the Terraced Streetscape District (TSD) has not developed as envisioned through the zoning ordinance and design manual. Several obstacles presented themselves to the development of the district, including, but not limited to pedestrian connectivity, traffic, and market demand challenges with property owners.

Elected Officials and the Planning Departments within Ferguson Township and State College Borough have expressed an interest in working together to overcome these challenges and create a walkable, mixed-use neighborhood that creates a gateway into both municipalities. The district starts at the Ferguson Township-State College Borough line just west of Buckhout St and West College Ave. It runs the length of West College Avenue stop to Blue Course Drive. MACKIN Engineering, along with Ferguson Township and State College Borough, will engage in this rewrite and plan for 3 public meetings in the future for citizen input.

Reminder: Updated Grass & Weeds Ordinance

With spring fast approaching, Ferguson Township would like to remind residents about our Grass & Weeds Ordinance, which was recently amended in December 2021 after our most recent spring and summer.

The most significant change to the Ordinance was the increase in permitted height of managed turf grass **from six inches to eight inches**. Other changes to the ordinance include incorporating "Grow Zones" into the definition of "Green Infrastructure." Please note that this ordinance applies to the R1 Residential District (Yellow areas on the 2020 Zoning Map).

Amendments to Official Ferguson Township Map



Ferguson Township is in the process of updating the Official Map of Ferguson Township. The Ferguson Township Official Map identifies priority areas for future growth — land where the Township may want to develop parks, streets, roads and natural area conservation.

The last update to the map was in 2017. The Ferguson Township Board of Supervisors have reviewed amendments to the map over the past year. Township Authorities, Boards, and Commissions such as the Planning Commission and the Pine Grove Mills Small Area Plan have also reviewed the amendments drafted by staff.

The timeline for public engagement and comment begins here:

Board Meetings:

- June 21—Ms. Dininni requested a discussion topic about the Musser Gap Trail being included on the OM map
- July 19th—That discussion continued.
- September 7th—The Board directed staff to draft an amendment to the OM.
- December 13—Board reviewed the draft and the draft ordinance will be prepared and presented for advertisement for public hearing at a future meeting.

PC Meetings:

- December 7—PC reviewed the draft amendments as provided by the Board and recommended approval of amendments.

PineSAP:

- January 27—Draft amendments, as presented to the Board, were reviewed on December 13 for review and comment.

Parks & Rec:

- March 10th—Draft amendments were reviewed as presented to the Board on December 13 for review and comment.

General Scam Safety

Don't be a victim to scams. There are many different methods scammers are using to steal your money. Here are some helpful tips to avoid losing money to these criminals.

Scammers can and do spoof their phone numbers. The scammers can make it look like they are calling from a local agency. Before providing any personal information over the telephone, be absolutely positively sure whom you are speaking to.

Scammers send emails pretending to be a legitimate company, friend or supervisor. If you come across a potential scam, be sure to:



- **Verify the email address.**
- **Before taking action, contact the company, friend or supervisor directly to verify the validity of the request.**

Scammers often use pressure and threats to get you to act immediately

- **Don't fall victim to the pressure.**
- **Obtain callers information but verify the legitimacy by reviewing previous bills, Internet search or other method**
- **Call a friend or local police to help verify the information**

Public Works News

Ferguson Township Public Works Building Goes Solar

In January 2022, Ferguson Township flipped the switch to "ON" for the 240 solar panels installed atop its Public Works Building 6. This solar system is comprised of 240 roof mounted 450 watt solar panels with inverter expected to generate 108 kilowatts of power. The energy consumption modeling for the building and size of the array are intended to produce a net zero energy building.

David Modricker, Public Works Director, reading from the Basis of Design for the building stated:



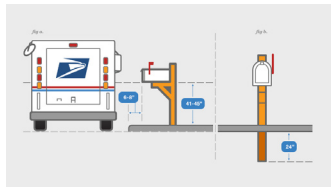

"...Ferguson Township adopted a Community and Environmental Bill of Rights in 2012. Among other things, it guarantees the right to 'a sustainable energy future.' Our most recent Strategic Plan commits us to excellent services, fiscal responsibility, environmental stewardship, and renewable energy. This building enables us to achieve those goals with high-performance work environments, sound long-term energy conservation and onsite renewable energy, and exceptional attention to environmental impacts. The Ferguson Township Board of Supervisors adopted a Net Zero Greenhouse Gas Emissions Resolution on June 19, 2017. The Resolution calls for us to make a plan for achieving net zero emissions no later than 2050, and to engage our governmental and non-governmental peers in the same. Finally, we are a Sustainable Pennsylvania Gold Certified community. This LEED Gold (certification pending) Public Works building helps us pursue goals aligned with our guiding documents and build on our reputation.

At 10:00am on January 28, 2022, Ferguson Township came closer to achieving its environmental goals for the future.

Post-Winter Mailbox Adjustments

After a long winter and plowing season, mailboxes can become damaged if not properly spaced along township roads.



The Township asks that residents adhere to these mailbox placement guidelines:

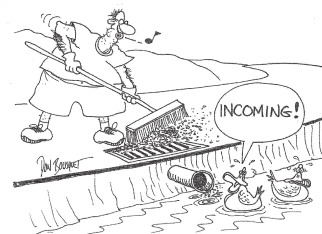
- Position your mailbox 41" to 45" from the road surface to the bottom of the mailbox or point of mail entry.
- Place your mailbox 6" to 8" back from the curb.
- Maintain three feet of clear zone below the mailbox, measured from the road surface. This allows room for the Township plow truck to clear snow from the street without damaging your mailbox.

"The spring is a great time to reset your mailboxes from potential damage from the winter," said David Modricker, Public Works Director for Ferguson Township. "Be sure to follow the US Postal Service guidance, and if it's in compliance with that, it will also be in compliance with Ferguson Township standards."

Public Works News

Route 45/Route 26 Construction



Construction is underway at the intersection of Route 25 & Route 26 in Ferguson Township as of March 4, 2022. The improvement is a \$5 million project through PennDOT, and is expected to be completed by mid-November of 2022.



"Concrete barrier will be installed, and Route 26 traffic will be shifted as necessary to allow construction of a temporary roadway. The temporary road will provide two-way traffic during the majority of the project. Traffic on Route 45 may also encounter restrictions during the beginning phases to allow for roadway widening" per a PennDOT press release.

The project also aims to increase lighting for further safety, and also includes adding a traffic signal and turning lanes to increase safety and provide less congested traffic in the area. 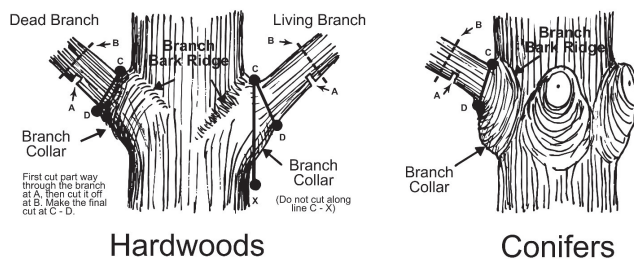
The Township Treebune: Proper Tree Pruning

With spring finally arriving and Township monthly brush collections about to begin, a number of residents are working feverishly to get their tree pruning completed and out to the curb. We would like to take this opportunity to provide some helpful hints in order to support you and encourage proper tree pruning principles.

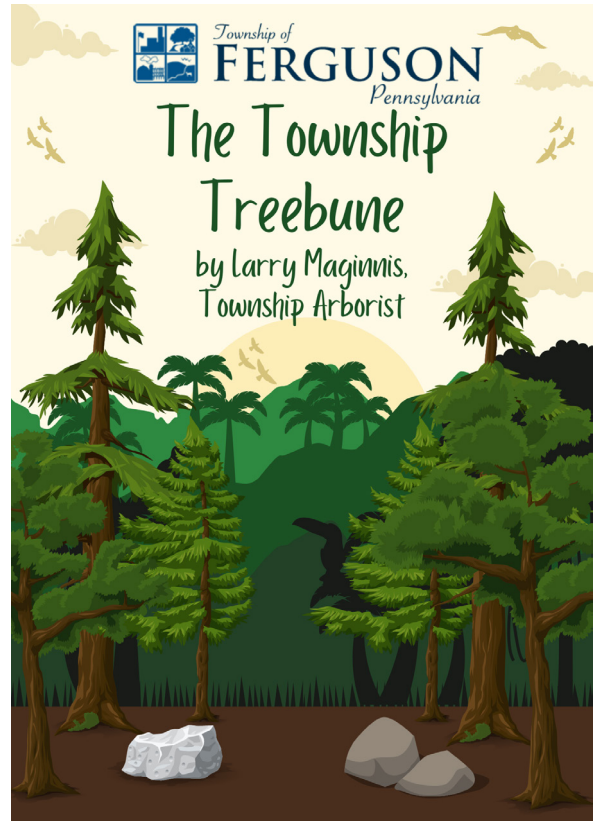
Tree pruning is very much a science and the standards for tree care have evolved to minimize the short term and long-term effects of pruning while maximizing the benefit for the homeowner. Before you begin pruning, visit this tremendous resource: www.treesaregood.org for some helpful hints. This website is chock full of information to help the homeowner maintain their trees properly throughout their life cycle.

A majority of homeowner tree pruning occurs for clearance purposes. Whether you are raising the canopy above a sidewalk, driveway, planting bed or pruning away from a structure be sure to adhere to proper pruning principles.

Proper Pruning Principles

To prevent the tearing of bark, employ this Three-Cut-Method as shown in the illustration. Practice identifying the branch bark ridge and branch collar at every branch attachment before you begin pruning. Regardless of where on the tree the branch cut is performed, never leave a long stub. To remove a branch, the final cut should be just outside the branch bark ridge and collar at the branch collar. To reduce the length of a branch, be sure to make the final cut at a branch attachment using the same principles.
