Mr. Miller seconded the motion. The motion failed by a vote of 2 -2 Mr. Miller and Ms. Whitaker for Mr. Buckland and Ms. Dininni opposed. Mr. Miller suggested three options for this tie: the chair be temporarily appointed, the Township Manager be temporarily appointed or have two representatives. Mr. Buckland made a motion appointing Ms. Dininni and Mr. Miller to the Parks Capital Committee. Ms. Whitaker seconded the motion. The motion passed unanimously.

VIII. APPOINTMENT TO POLICE PENSION ADVISORY BOARD

Ms. Whitaker made a motion appointing Ms. Whitaker to the Police Pension Advisory Board. Ms. Dininni seconded the motion. The motion passed unanimously.

IX. APPOINTMENT OF CONSULTANTS FOR FEDERALLY FUNDED PROJECTS

Mr. Kunkle stated that the Township has one project that may receive Federal funding through the Centre County Metropolitan Planning Organization. This project is a Streetlight/Sidewalk Project located in Pine Grove Mills. By making this appoint of the engineer, the Township can avoid the process of selecting consultants for a small project such as this. Staff is recommending that Stahl Schaefer Engineering be appointed as Engineer for federally funded projects and Aumiller Appraisal Services for land acquisitions.

Ms. Dininni made a motion to APPROVE the consultants as Stahl Schaefer Engineering and Aumiller Appraisal Services. Mr. Buckland seconded the motion. The motion passed unanimously.

X. ESTABLISH MEETING DATES FOR 2016

Ms. Dininni made a motion that meetings be set for first and third Monday of each month for 7pm, with certain exceptions for holidays and the December meetings to be held on the first and second Mondays. Mr. Buckland seconded the motion. The motion passed unanimously.

XI. DESIGNATION OF DEPOSITORY

Ms. Whitaker made a motion that the Township remain with Jersey Shore State Bank as their primary depository and any FDIC insured bank and the PA Local Government Investment Trust for the Township investment policy for the year 2016. Ms. Dininni seconded the motion. The motion passed unanimously.

XII. CITIZENS INPUT

Mr. Keith Farwell, 149 East Aaron Drive, stated his hope is to have no animosity in any individual working on the Board of Supervisors.

Mr. Joe Cusumano, resident, stated the Board needs to work together to get the job done for the people. He commented about the law suits filed by the Township.

Mr. George Pytel, resident, reminded the new Board members to remember what they said when they were sworn in. He also stated that the Home Rule Charter is the law.

Mr. Bob Lindsay, 3296 Shellers Bend, asked about the process for filling the vacancy on the Board.
