# 2. UPDATE ON SONGBIRD SANCTUARY PHASE 1

#### **Narrative**

The Board of Supervisors approved the Songbird Sanctuary Park Master Plan by resolution. Master Planning for this park has been underway since 2019 with a steering committee, comprised of staff and residents, organized to have a multidisciplinary approach for a collaboration methodology. The Ferguson Township Public Works Department (FTPW) began constructing Songbird Sanctuary Park – Phase 1 earlier this year. To date, FTPW began clearing of trees and brush for a natural perimeter trail. FTPW will continue to dedicate time to construct Phase 1 over the next couple of months.

# 3. UPDATE ON HOMESTEAD PARK PLAYGROUND

#### **Narrative**

Ferguson Township Park and Recreation Committee Thursday, March 10, 2022

The Board of Supervisors accepted the Parks and Recreation Committee's recommendation to install the suggested playground equipment. The Board of Supervisors received a petition opposing the suggested location for the playground equipment installation. The Board approved the playground equipment and voted to have poured-in-place rubber surface area installed at the playground site. Poured-in-place is an ADA accessible material and serves as the first ADA surface area installed in Ferguson Township. The installation is complete and the township's playground safety inspector provided an inspection report. There are a few items to be completed by the contractor prior to the playground equipment being opened for use. The Township will provide a notification on the website and on social media when the playground site is available for the public.
