VI. NEW BUSINESS

1. FERGUSON TOWNSHIP OFFICIAL MAP AMENDMENT Kristina Bassett, Community Planner

20 minutes

Narrative

Planning & Zoning staff has been updating the Ferguson Township Official Map at the request of the Board of Supervisors. An Official Map is a planning tool that may guide the Township in its decision-making with respect to land use regulations, acquisition of property for public use, and general planning efforts. Some of the proposed amendments are in the Village of Pine Grove Mills, and should be viewed in the context of the Small Area Plan. Kristina Bassett will introduce the item and review the relevant areas for discussion by the Small Area Plan Advisory Committee. Like a Small Area Plan, an Official Map is for planning purposes and does not inherently change a property's permitted uses, dimensional constraints, public accessibility, or other features. If a property is designated for public use on an Official Map, there is a one-year suspension of the review period for subdivision and land development proposals once submitted, during which the Township may acquire the property if desired through fee simply negotiations or through the Eminent Domain process, if otherwise permitted by law. Provided with the agenda are several attachments to help facilitate the discussion, and linked below is the current Ferguson Township Official Map. It is worth noting that this is separate and distinct from the Zoning Map.

2. CECIL IRVIN PARK PHASE IA DEVELOPMENT UPDATE David Pribulka, Township Manager

Narrative

Ms. Grove has requested an update on the Phase IA development plans for Cecil Irvin Park. The Township is proposing to submit a grant application to the Department of Conservation and Natural Resources' Community Conservations and Partnerships Program in 2022 for construction in 2023. Amenities in the proposed park include off-street parking, pavilion, and accessible walking path. Also discussed was the introduction of an amphitheater for community events. Ms. Grove has suggested consideration of a pétanque space, which is a French sport akin to bocce ball. An article is linked to below with a further description of the game. Provided with the agenda is the draft site plan from a previous grant application for the park's development. This item is for discussion only and no action is being requested at this time.

II. CALL TO ORDER

The Pine Grove Mills Small Area Plan Advisory Board was called to order on Thursday October 28, 2021 at 4:00 pm.

The Committee discussed the traffic signal warrant study that the intersection of Pine Grove Road and Water Street. Different traffic calming measures were evaluated and alternative methodologies were explored for signal warrant analyses.

b. PINE GROVE MILLS SMALL AREA PLAN IMPLEMENATION PLAN UPDATE

Ms. Grove asked for items to post to the Pine Grove Mills social media account. Additionally, she reported about the pop-up markets taking place at Pine Grove Hall. The next will be a holiday market on December 5th from noon to 4:00. The Committee discussed the development of Phase IIA of Cecil Irvin Park and how it helps to advance the objectives of the Small Area Plan. Specifically, the conversation focused on the construction of an amphitheater and different design alternatives. Grant

The Committee also discussed incorporating history and heritage into the parkland development.

Ms. Holliday inquired about whether the Committee would be interested in getting involved in an "Our Town" segment from WPSU. The Committee supported moving forward.


VIII. STAFF REPORTS




Having no further business to attend to, the meeting was adjourned at 6:00 p.m.
