1. PINE GROVE MILLS FARMER'S MARKET REPORT

Narrative

The Pine Grove Mills Farmer's Market began in 2018 and is now entering its fourth year operating at St. Paul Lutheran Church. This year, the Market announced it was approved to accept SNAP benefits to assist individuals and families in achieving food security by providing healthy local options. II. CALL TO ORDER

The meeting was called to order at 4:00 p.m.

III. CITIZEN'S INPUT

No Citizen's Input was heard.

IV. SMALL AREA PLAN IMPLEMENTATION SCHEDULE AND PRIORITIZATION – WORKSESSION

Chairman Heller introduced the item. Chairman Heller reviewed the spreadsheet prepared to assist the Committee in assigning priority to the Small Area Plan action steps. The Committee reviewed and discussed the criteria in the spreadsheet. The Committee went through an example of the prioritization of an action step and discussed changes to the model. The Committee members will make their respective additions to the spreadsheet in advance of the May meeting.

V. HAPPY VALLEY ADVENTURE BUREAU TOURISM GRANT APPLICATION – "ROUTE 45 GETAWAYS"

The Committee discussed the application to the Happy Valley Adventure Bureau Tourism Grant Program. The grant, if successful, would defray the costs associated with marketing and hosting a week-long event taking pace in Millheim Borough and Ferguson Township, as well as the connecting segment of Route 45. Ms. Grove and Mr. Tomkiel reviewed the partners that have agreed to participate in the event. Additionally, the Committee reviewed the marketing budget and business plan. A follow-up report will be provided to the Committee once the grant results are made public. Ms. Grove moved that the Committee authorize a letter of support for Ferguson Township's application to the Happy Valley Adventure Bureau Tourism Grant Program for Route 45 Getaways. The motion carried unanimously.

Mr. Robb inquired about the process for drafting the letter of support for the Tourism Grant. Mr. Pribulka responded that he would draft the letter and share it with the committee for any edits.
