### **Contract 2018-C20 Park Hills Drainageway Addendum Number 1**

This addendum shall be considered a part of the Contract Documents and Specifications for the above referenced project and shall be enforced as if written originally.

1. Contract documents and specifications
  - a. Information for Bidders:
    - i. Revised the date and time that bids are due to be Tuesday October 3, 2023, at 2:00 PM with the bid opening immediately following in Conference Room 2.
  - b. Bid Form:
    - i. Revised to acknowledge Addendum 1
  - c. Special Provisions:
    - i. Item 9000-0027: Revised language to require the as-built survey to be completed in stages as the project is being constructed and that payment for work completed will be approved after the as-built survey is provided and validated.
  
2. Plans for Contract 2020-C4, dated December 20, 2022, and revised by Addendum No. 1 dated February 10, 2023 are attached hereto and hereby issued. They incorporate the following changes:
  - a. Sheet C101:
    - i. Revised Demolition Notes 3 and 4 to reflect utility work consistent with the Contract Documents.
    - ii. Added general note to document that the existing conditions on the plan are as surveyed in 2019 and that additional erosion has occurred since that time and that the contractor is to account for these conditions within the bid.
  - b. Sheets C401 through C406:
    - i. Corrected plan to properly depict all hatching on the erosion and sediment control plan consistent with the legend.
  - c. Sheets C602 through C605:
    - i. Corrected Note 1 to properly reference the sheet C304 instead of sheet C505 for the sewer lateral concrete encasement detail.
  - d. Sheet C606:
    - i. Revised Existing Note 6 to reflect utility work consistent with the Contract Documents.

**All bidders must use the addendum bid proposal form. Failure to do so will subject the bidder to disqualification.**

The date and time for the bid opening is hereby changed to Tuesday, October 3, 2023 at 2:00 pm at the Ferguson Township Building.
