Introduction:

To respond to additional Requests for Information (RFI), Ferguson Township is providing this information for prospective bidders to use in preparing their bids for Contract 2018-C20 Park Hills Drainageway.

Additional Requests for Information and Responses:

- 1. Is there any cost to the contractor for the Township Arborist's time on site?**
 - a. No, the Township will not charge the contractor for any of our employees or consultants who are onsite while the contractor is performing the work.

- 2. Page C-900, note #3. Does the Twp. Arborist satisfy this requirement to be on-site during all tree removal, trimming and root pruning?**
 - a. No, the contractor is to have their own certified arborist onsite for all tree removal, tree trimming, and root pruning. The Township Arborist may be onsite for observation and coordination but will not be responsible for overseeing the work.

- 3. On page C906 there is an area with a herringbone pattern with no explanation. What does this represent?**
 - a. The area with a herringbone pattern is a carry-over from the Erosion and Sediment Control Plan as depicted on Sheet C406.

- 4. Could clean sheets depicting the utility work, waterline & sanitary be issued?**
 - a. No additional drawing sheets will be issued; however, we will answer any questions there may be regarding the scope of the utility work as described on the plans and in the specifications.

- 5. Does the UAJA's scope of work include all of the temporary & permanent restoration? I'm thinking soil stabilization, E & S measures and paving.**
 - a. UAJA will not be responsible for restoration of the vegetated area where they will be installing their new sanitary sewer main. They will be responsible for repairing the pavement and curb where they connect to Princeton Drive. All utility work will need to be coordinated.

- 6. Could a list of plan holders be sent to bidders?**
 - a. The current plan holder list is attached to this response. This list may change if additional bidders request documents.
