## FERGUSON TOWNSHIP WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT

In consideration of permission granted by Ferguson Township allowing it to operate the Company's mobile food facility in a public right-of-way or public park, which will occur on
, the undersigned officer of the Company, represents, covenants and agrees on behalf of itself, its successors, assigns, and any other person claiming by, under or through it, as follows:
1. The Company acknowledges that operating a mobile food facility in a public right-of-way or public park involves certain risks and that injuries, death, property damage or other harm could occur to it or others. The Company accepts and voluntarily incurs all risks of any injuries, damages, harm, or claims of liability which arise during or as a result of the Company's mobile food facility operations in public rights-of-way or public parks, including any associated travel, regardless of whether or not caused in whole or in part by the negligence or other fault of Ferguson Township, and/or its departments, affiliates, employees, officers or agents ("Released Parties").
2. The Company waives all claims against any of the Released Parties for any injuries, damages, losses, or claims, whether known and unknown, which arise during or as a result of the Company's mobile food facility operations, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. The Company releases and forever discharges the Released Parties from all such claims.
3. The Company agrees to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that the Company (or anyone claiming by, under or through the Company) may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or as a result of the Company's mobile food facility operation in a public right-of-way or public park, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties.
4. The Company has carefully read and reviewed this Waiver, Release and Hold Harmless Agreement. The Company understands it fully and executes it voluntarily.
