## **New Telecom Infrastructure Coming to Ferguson Township**



In May of 2022, Ferguson Township, along with C-NET, began the process to negotiate a franchise agreement with Shenandoah Cable Television, LCC ("Shentel"), under their Glo Fiber brand, for the provision of cable television services within the Township. A cable franchise agreement with Shentel was approved by the Board on January 17, 2023.

Currently, Ferguson Township has a franchise agreement with Comcast and will continue this agreement. The addition of Glo Fiber's infrastructure will provide a greater range of telecommunications options for residents. Construction is currently slated to begin in 2024.

## **Township's New Agenda and Meeting Management Solution**



Ferguson Township has partnered with CivicPlus to implement its CivicClerk agenda and meeting management solution. The Township will use the software to streamline the automation of its agenda and meeting minutes management processes and enable convenient access by citizens to public records.

Citizens will also benefit from such conveniences as the ability to download PDFs of agendas, meeting minutes, agenda packets, and other documents, and have access to a dedicated citizen portal with email subscription capabilities.

### Register Your Parking Permit on Our New T2 System



On March 14, 2023, the Township's new mobile-friendly parking ticket and permit management system went live.

The Ta System provides the Township with the tools and The T2 System provides the Township with the tools and technology needed to manage parking and mobility, while

its real-time citation data allows customers to pay for a ticket, view photos related to a citation and submit appeals from their mobile device. The Township will still accept payment in-person, by cash or check, at the Ferguson Township Municipal Building.

Streets Requiring a Parking Permit: Rushcliffe Street, Beaver Avenue, Butz Street, Highland Alley, Corl Street, Hoy Street, and Osmond Street

## Who Needs to Register?

Both homeowners and tenants parking in the areas above need to register. Homeowners with parking permits are required to register their vehicles annually in the T2 System for free; tenants are required to register their vehicles annually for a fee of \$15.

### **Lock Crime out of Your Home**

**Doors & Windows:** Keep locked when you leave home. Do not give criminals easy access to your residence. Locked entries discourage most criminals.

**Security Cameras:** Consider installing doorbell or other security cameras that provide real-time alerts to your mobile device. These cameras have been helpful in solving many crimes.



**Environmental Design:** Keep bushes and shrubs trimmed so criminals can't hide around your residence.

**Lighting:** ensure the exterior of your residence has sufficient lighting so unwanted individuals can be easily seen. Install dusk to dawn lights and motion detector lights.

**Alarm System:** Consider installing an alarm system to notify police. An audible alarm should scare off most burglars. It will not only alert you, but neighbors as well.

**Get to know your neighbors:** Have them keep an eye on your residence when you are away and to report any suspicious activity to police.

#### **2022 Street Tree Inventory**

Ferguson Township conducted a street tree inventory in 2022. The Township's publicly maintained trees are an ecosystem service investment benefiting current and future residents. Managing this investment requires periodic census surveying of each tree to ensure tree health and public safety.

The Township Arborist evaluates trees weekly throughout the township. For this comprehensive Township Inventory, Penn State Urban Forestry Extension was contracted to perform the on-site inspection, data recording and analysis.

**Help Prevent Oak Wilt: Tree Pruning Ban** 

The Township Arborist, Larry Maginnis, would like to



remind residents of Township Ordinance 1023, which prohibits the pruning of oak trees from April 1 through October 31.

Oak wilt is a fungal disease that affects oak trees, and as infected trees cannot be cured, spread prevention is critical.

The disease is transmitted by beetles which are attracted to fresh wounds in a tree's outer layers. Such wounds are

caused by pruning limbs and climbing trees using spurs or spikes.
