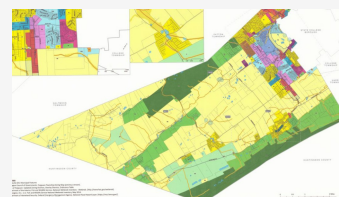
## Planning & Zoning News
