11. CALL TO ORDER

Vice chair Dr. Marc McDill called the Monday, July 13, 2020 Ferguson Township Tree Commission (FTTC) meeting to order at 5:07 pm in the absence of Mr. Scott Pflumm.

Dr. McDill called for a motion to approve the June 15, 2020 meeting minutes. Dr. Michael Jacobson made a motion to approve, Mr. Josh Potter seconded the motion, and the motion passed unanimously.

VI. PROPOSED TREE REMOVALS 2020

Mr. Lance King stated that the tree removal tour will be done via a PowerPoint presentation this year due to COVID-19. Mr. King stated that he went through the Township and made a list of trees that needed to be removed and had some resident request for removals. Mr. King made a presentation with pictures of the trees that need removed, the location, and the proposed replacement. Mr. King started the presentation.

1. 110 S. Osmond – resident called Mr. King to request this tree to be taken out. Mr. King stated that this is not a tree that was planted by the

Township and the resident was not requesting a replacement for it right now.

2. 110 Sunday Drive – proposed replacement Little Leaf Linden.

Mr. King noted that the tree planting this fall will be done in house with bare root seedlings from Schichtel's Nursery in New York. The Commission discussed the tree planting plan.

Mr. Glebe asked if there is anything wrong with the soil in this area. Mr. King stated that he hasn't done any soil testing but there are other tree species in this area that are doing well.

- 11.2460 Autumnwood Drive proposed replacement: Kentucky Coffee Tree
- 12.3221 Shellers Bend proposed replacement: Hop Hornbeam.
- 13. Near Foxpointe development sign on Pinehall Road by American legion proposed replacement: Little Leaf Linden.
- 14. Old Gatesburg Road median proposed replacement: Hop Hornbeam.
- 15. Old Gatesburg Road North side near Science Park Road proposed replacement: Sargent Cherry.

The Commission discussed the bad soil that is located in this area from previous construction. Mr. Modricker noted that conifer trees do well in this location.

- 17. Across from 1879 Pinehall Road proposed replacement: 2 Canada Red Cherry.
- 18.135 Havershire Blvd Proposed replacements: 2 Little Leaf Linden.

- 20. 1196 North Foxpointe Drive proposed replacement: Kentucky Coffee Tree.
- 21.1248 Longfellow Lane proposed replacement: Triumph Elm
- 22. 1342 Sconsett Way- proposed replacement: Tulip Poplar
- 23.1351 Sconsett Way proposed replacement: Kentucky coffee tree
- 24. 1371 Sconsett Way proposed replacement: Hop Hornbeam.
- 25. 1415 Megan Drive proposed replacement: Little Leaf Linden.
- 26.1470 Martin Street proposed replacement: Canada Red Cherry.

- 27.1521 Martin Street proposed replacement: Canada Red Cherry.
- 28.1540 Martin Street proposed replacement: Hop Hornbeam.
- 29.1615 Glennwood Circle The resident request this tree be removed. Note that the Township did not plant this tree and the resident is not requesting a replacement.
- 30.2404 Cobble Ct proposed replacement: Tulip Poplar.
- 31. In the Heights Across from 118 Southwick proposed replacement: Little Leaf Linden.
- 32. Blue Course Drive median at Old Gatesburg proposed replacement: Kentucky Coffee Tree. Mr. King noted that this tree was hit by a car, the Commission decided that they would like to try and save this tree.
- 33. Havershire Blvd Mr. King noted that this tree was also hit by a car. The Commission decided that they would like to try and save this tree.
