III. APPROVAL OF MINUTES

Dr. Marc McDill called for a motion to approve the April 17, 2023 meeting minutes. Dr. Michael Jacobson seconded the motion, and the motion passed unanimously.

a. EDUCATION & OUTREACH

Mr. Scott Pflumm stated that there is a small change it the Education and Outreach articles. The neighborhood map article that was supposed to be published this month has been moved to next month.

b. ARBOR DAY 2023 DEBREIF

Mr. Larry Maginnis stated that the 2023 Arbor Day was a success. Mr. Maginnis provided an overview of the day to the Commission including photos. Mr. Maginnis stated that he is already making plans to make the event even bigger next year by including additional employees and tree care professionals to help with bucket truck rides and an "ask an arborist booth" kids climb and other events. Next year will be April 27th at 11:00 a.m. at Tudek Memorial Park. Tabling and vendors will be added. Dr. McDill suggested inviting students to help with the event.

c. 2023-2028 URBRAN FORESTRY MANAGEMENT PLAN

Mr. Maginnis distributed the revised 2023-2028 Urban Forestry Management Plan. Mr. Maginnis compiled the Commission and staff comments and made the appropriate revisions. Mr. Maginnis stated that he has included a signature page for the Arborist, Chair, and Secretary to sign if approved. The Commission discussed the process of what will happen to the plan once

Mr. Maginnis exhibited the Township's newsletter article regarding the mulch volcanoes. The Commission discussed in length how well this campaign has done.
